State Structure

Kentucky's delinquency services are organized at both the state and local level. Nearly all community supervision in Kentucky is administered by the Department of Juvenile Justice, a state-level juvenile corrections agency; however, a couple of counties have locally court administered probation. Secure detention is similar in that most facilities are administered by DJJ. The DJJ administers both commitments to state public facilities and aftercare services for youth leaving state facilities.

Status Offenses

In Kentucky, being beyond the control of school or beyond the control of parents, being a habitual runaway, habitual truancy, and tobacco and alcohol offenses are status offense behaviors. Status offense cases are classified as status offenders. The family court has jurisdiction over status offenders, while the district court has jurisdiction over delinquents.
