## Status Offenses

In New Mexico, being a runaway, a truant, and/or a juvenile who has committed a status offense that is not classified a delinquent act (exception: out-of-state runaway juveniles as mandated by state and/or federal law) are status offense behaviors. Status offense cases are classified as status offenders or families in need of services. The Children's Court Division of the District Court has jurisdiction over status offenders and delinquents.
